BDDA Board Meeting Minutes March 11, 2020

The Downtown Development Authority of Blackman Charter Township held a Board meeting at 7:00 a.m., Wednesday, August 12, 2020 via Zoom.

Members Present (8): Mike Ambs, Roger Auwers, Dan Decker, Kevin Ganton, Don Hoadley, Pete Jancek, Jeff Kinney, and Greg Vogt

Members Absent (2): Rebecca Roberts and Steve Shotwell

Others Present: Jack Ripstra, Township Engineer and Evelyn Markowski, Township Assessor

Staff: Emily Cones, Debbie Kelly and Alex Masten, The Enterprise Group of Jackson

Chairman Jancek called the meeting to order at 7:04 a.m.

Public Comment: None.

Meeting Minutes of March 11, 2020:

Mr. Auwers moved to approve the BDDA Meeting Minutes for March 11, 2020, with Mr. Ambs supporting. Unanimously approved.

BDDA Invoices through June, 2020:

Mr. Auwers moved to approve the June, 2020 BDDA Invoices totaling \$279,940.15 as presented, with Mr. Kinney supporting. Unanimously approved by roll call vote.

Consider Purchase Offer for Parcel 179 for \$19,000 and Parcel 176 for \$14,000:

Mr. Auwers asked if selling parcels 176 and 179 impacts the usage of greenspace and Mr. Ripstra replied no, that it will likely be used as a water retention pond. Chairman Jancek informed the Board that he will share the offers with the attorney for review before signing any documents. *Mr. Auwers moved to approve the purchase offers for Parcel 179 for \$19,000 and Parcel 176 for \$14,000, as presented, with Mr. Ganton supporting. Unanimously approved by roll call vote.*

Updates:

BDDA and County Property:

Ms. Kelly shared an update regarding the EDA grant in which the Blackman Charter Township Local Development Finance Authority is pursing stating that JCDOT is in the process of reviewing public comment, and we hope to get a final approval for the grant anytime now.

Chairman and Board Comments/Updates:

Chairman Jancek provided an update of ongoing roadwork including the bridges on West Avenue, Elm Street and Lansing Avenue.

Mr. Auwers stated that students will be starting at the Torrent Center and Career Center in person on August 26th. He stated plans are in place according to state regulations and are subject to change.

Mr. Kinney mentioned that CP Federal Credit Union staff are extremely busy with loan applications.

Next Meeting:

The next Blackman Charter Township Downtown Development Authority meeting is scheduled for Wednesday, September 9th, 2020 at 7:00 a.m. and will likely be held via Zoom.
