## **Board Meeting Minutes February 16, 2022**

The Local Development Finance Authority of Blackman Charter Township held a Board Meeting at 6:00 p.m., Wednesday, February 16, 2022, at the Blackman Charter Township Meeting Hall.

**Others:** Jack Ripstra, Township Engineer; Ray Snell, Jackson County Commissioner; Stephanie Hinkle, Blackman Charter Township Deputy Assessor; Arnold Dolman, Blackman Charter Township Assessor; Phil Preston, Blackman Charter Township Treasurer; and Joe Bentschneider, Jackson County Department of Transportation

The BLDFA Board Meeting was called to order by Chairman Jancek at 6:00 p.m.

## **Public Comment:** None

## **Approval of Minutes from December 8, 2021 Board Meeting:**

Motion by Ms. Derby and seconded by Ms. Pitchford to approve the Minutes from the December 8, 2021 Board Meeting. Motion approved unanimously.

## **Treasurer's Report through January 31, 2022:**

The current administrative fund balance available is \$753,045.47. Motion by Mr. Elwell and seconded by Mr. Norris to approve the Treasurer's Report through January 31, 2022 as presented. Motion approved unanimously by roll call vote.

Introductions were made around the table.

### **EDA Grant Update:**

Mr. Bentschneider from the Jackson County Department of Transportation attended the meeting. Ms. Kelly thanked him and Mr. Riptra for their work with the EDA Grant. Special Award Condition # 13 for evidence of Good Title requirement is done and is getting reviewed by our EDA representative for final submittal. Mr. Bentschneider provided a timeline stating that in April bid letting will begin, as well as more advertising. He added that there will be more information for the public at this time. He stated that park infrastructure and the road will begin in May or June, and he is hopeful that infrastructure into the

park will be done by November begin receiving commitments from potential tenants as early as winter of 2022 and the spring of 2023. He mentioned that improvements to County Farm Road will begin in 2023, and that signals take about one year to order. New tenants can build during the same time that the improvements are being made to County Farm Road. Mr. Bentschneider included that the cost estimate is padded and he is confident that it will be covered by the grant. He updated the board that there are a total of 17 easements in which 12 have been received. He stated that three of the easements they were unable to obtain will not affect their plans, the fourth was a resident who did not wish to comply, but they are able to work around it. The last easement they were unable to obtain was the JSP property because they are currently trying to sell, so there will be a shortened sidewalk which will not go through the JSP property. Mr. Bentschneider informed the Board that the Township offered to pay for those easements and that he will get a total cost for the Board. Chairman Jancek reminded the Board that the Blackman LDFA will be responsible for maintaining the sidewalks for five years, and then it becomes the property owner's responsibility.

## **BLDFA Properties Update:**

Ms. Masten stated there is nothing new to share about Technique.

### **Board/Staff Comments:**

Mr. Elwell gave an update on the Poor Farm Cemetery which was established in 1839. He shared that he applied for a historical society marker, which was approved two months ago. He also received a grant and wants to hold an event in May, prior to construction starting at JTPN. He stated there are 70 names of people buried there, and the records have been burned. He is applying for a local and state designation which is a \$250 fee. Mr. Elwell asked the Blackman LDFA Board to approve expenses for the historical society marker which is \$3,900. Motion by Mr. Elwell to authorize a letter that the Blackman LDFA will pay for the cost of the marker. Seconded by Mr. Linabury. Unanimously approved by roll call vote.

Mr. Elwell shared that he is talking with the county to do ground penetrating radar at the cemetery, which JCDOT will do. Mr. Ripstra has done the rendering for parking at the cemetery and wants to put a fence around it also. Mr. Elwell stated that the Township asked him to do research on the other two township cemeteries with Ms. Sercombe, Blackman Charter Township Clerk. He stated there is funding available for upkeep.

### **County Update:**

Commissioner Snell stated that the county is considering expanding the 911 dispatch center, and the Chanter Road jail. The county is also looking to demolish the building on Wesley Street. Chairman Jancek stated that Region 2 Planning Commission is tasked with auditing the county's buildings and properties to get an idea of what can be done. He also wants to look at current assets and decide what makes sense for future development.

The next BLDFA meeting is scheduled for Wednesday, May 18, 2022 at 6:00 p.m. at the Blackman Charter Township Meeting Hall.

Meeting adjourned at 6:37 p.m.


